A. Following nationals need not to pay any visa fee (Gratis): **Argentina** (only Business, Tourist and Transit visa), Bangladesh, Democratic People's of Korea, Jamaica, Maldives, Mauritius, Mongolia, South Africa and **Uruguay** (only Tourist Visa). In respect of **Seychelles** nationals, all types of visas except for Work/Employment may be issued on **Gratis** Basis.

B. Nationals of **Nepal** and **Bhutan** do not need visa to enter India. However, Nepali nationals require visa if they enter India from China, which may be Gratis basis.

C. For Pakistani nationals, Visa Fee is **Rs 100/- (Nle 25.00) plus Nle 75.00 as ICWF. (Total Nle 100.00 (Roundoff)).**

D. Fee for Transfer of Visa from an old passport to new passport is **USD 5/-** i.e. Nle 2.00 plus SLL 75.00 as ICWF. **(Total Nle 77.00).**

Special Visa Fee Categories: In view of the existing bilateral agreements/arrangements, Visa fee in respect of the following countries will be as follows:

- **Singapore** nationals: The charges for Tourist Visa (Multiple Entry) and validity upto 06 (Six) months will be **USD 25/-**. However, Fee for all other types of visas will be same as applicable for other countries nationals. The **revised Tourist Visa Fee is Nle 700.00 (inclusive of Nle 75.00 for ICWF).**

- **Japanese** nationals: A fee of **USD 01/-** (one) for Transit visa and **USD 08/-** (eight) for all other types of visas may be charged from **Japanese** nationals.

Transit Visa : Nle 100.00 (inclusive of Nle 75.00 for ICWF).

Other Types of Visa : Nle 275.00 (inclusive of Nle 75.00 for ICWF).

- **US nationals:** A Fee of USD 160/- may be charged for **Tourist and Business visas** for the maximum period of upto 10 years for any entry. However, Fee for all other types of visas will be same as applicable for other countries. **Visa Application Fee of USD 20/- to be charged from US nationals in addition to visa except Tourist and Business Visa.** The Fee should be as follows:
